1. PURPOSE:

- 1.1 To prepare food with specifications proper for cooking and serving.

2. DEFINITIONS:

- 2.1 Process of Food Preparation – each dish preparation with specification.

3. POLICY:

- 3.1 Food preparation in Maternity and Children Hospital, Hafer Al Batin should comply with the requirements of the system.

4. PROCEDURE:

- 4.1 Supplies needed for each dish preparation are taken out from the reach in cold rooms or freezers or form shelves in case of dry supplies.
- 4.2 Frozen products are left at 5°C to defrost or thaw:
- 4.2.1 Once raw meat products are defrosted they must be consumed within 24 hours and cannot be made frozen again.
- 4.3 Fresh products like vegetables and fruits are soaked in a chlorinated solution and washed thoroughly with minimum of 10 minutes washing time.
- 4.4 Dry or refrigerated or canned products are washed properly before being used.
- 4.5 If all checked items conform to the quality requirements, each dish is prepared following asset menu and the production process is carried out.
- 4.6 Once the food is prepared and ready to be served, the diet clerk must carry out a final evaluation of the food form appearance to taste.




